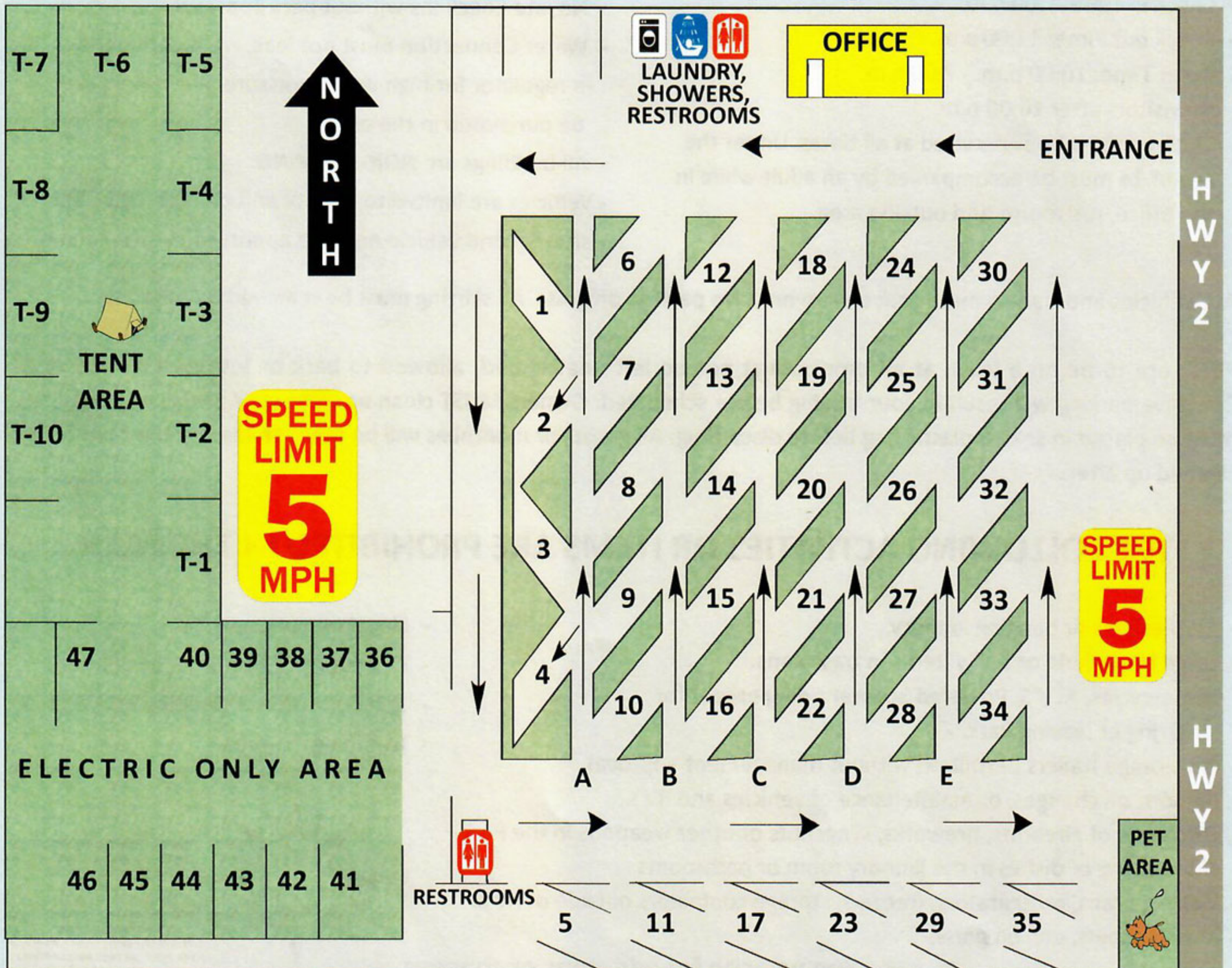

- Any guest or visitor who violates our Park Rules may be asked to leave without warning and without a refund.

- Office Hours: Monday - Sunday
Summer 9:00 a.m. - 5:00 p.m. June 1st - Sept. 30th.
Winter 9:00 a.m. - 1:00 p.m. Oct. 1st - May 31st
- Check in Time: 1:00 p.m.
- Check out Time: 11:00 a.m.
- Quiet Time: 10:00 p.m. - 7:00 a.m.
- No visitors after 10:00 p.m.
- Children must be supervised at all times. Under the age of 14 must be accompanied by an adult while in the office, restrooms and outside area.
- Trash is to be bagged and placed in dumpsters only.
- Sewer Connection must be tight and sealed. Must use elbow and screw into place.
- No late Check-ins without park approval.
- Water Connection must not leak, we recommend a regulator for high water pressure. Regulators can be purchased in the office.
- All buildings are NON-SMOKING.
- Vehicles are limited to one RV and one car/truck per site. Second vehicle must be approved by management.

ALL Vehicles and trailers must park on site only. No parking on grass. All skirting must be removed by June 1st.

PETS: are to be on a leash at all times, must not be left unattended, allowed to bark or tethered unattended. Excessive barking will result in your leaving before scheduled. Owners MUST clean up after your pet/s and droppings must be placed in sealed plastic bag before discarding. All guests or monthlies will be asked to leave if their pet is not cleaned up after.

THE FOLLOWING ACTIVITIES OR ITEMS ARE PROHIBITED IN THE PARK

- Clotheslines or hanging laundry.
- Large household or bulky items in trash cans.
- Motorcycles, ATV'S, Powered Scooter riding except for entering or leaving Park.
- No storage trailers permitted without management approval.
- Repairs, oil changes, or maintenance of vehicles and RV's
- Discharge of Firearms, fireworks, slingshots or other weapons in the Park.
- No washing of dishes in the laundry room or bathrooms
- Garbage cans, refrigerators, freezers, storage containers outside of RV's.
- Mats, carpets, etc. on grass.
- Illegal narcotics.
- Processing of fish or game animals.
- Tents or outdoor sleeping on RV sites.
- Trimming of Trees.
